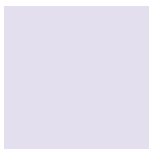

Peter Bowler

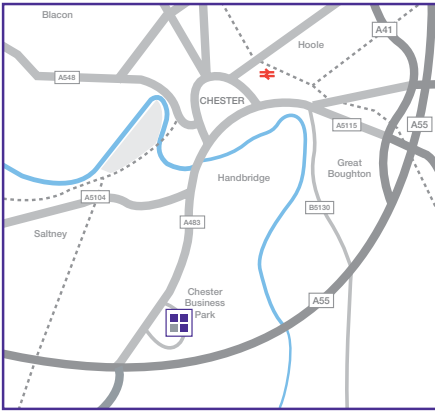

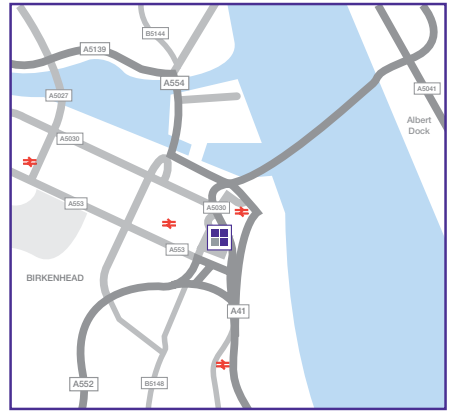
